



Office-Based Opioid Treatment (OBOT) for Adolescents

These are providers who are not licensed as an Opioid Treatment Program (OTP) who administer buprenorphine or naltrexone for OUD MAT treatment for adolescents. OBOT providers are physicians and mid-level providers authorized via a Data 2000 Waiver to use buprenorphine or naltrexone to treat Opioid Use Disorder out of their office setting.
